I flew to Vancouver, Canada, and had the privilege of serving as the chairman of the Independent Observer (IO) Program that is charged by the International Olympic Committee (IOC) and the World Anti-Doping Agency (WADA) to ensure that athletes compete fairly and drug-free in the Olympics. My team consisted of ten people from around the world (Kuwait, Germany, UK, Luxembourg, Canada, Australia, Norway, Latvia, Japan and the U.S.) who are lawyers, doctors, laboratory directors and sports and doping experts. I had a front row seat at the opening and closing ceremonies, saw every major event and had a hotel balcony view of the Olympic flame and Olympic rings. I was honored to represent NDAA (the opening Olympic Press Conference made clear that I was associated with America's district attorneys) and I hope I was able to spread a little good will for all of us around the world.

Upon my return, I encountered all of the things that we (NDAA) have been working on over the past year (IG audit, grant applications, NAC funding, John R. Justice Loan Forgiveness funding, the Webb Commission, National Academy of Sciences Report, Executive Working Group with AG Holder, Web site upgrade, College course attendance, policies and procedures drafting, and a hundred other issues); and I also encountered the incredible people that make up NDAA who go to work every single day to support the great work of prosecutors across our country. I attended our Board meetings in Charleston in April and updated the Board with respect to our financial situation (our number one priority) as our long Inspector General's Audit is winding down. I want to thank those brave soles that came to our NDAA Capital Conference (especially those that were snowed-in and stranded in the Liaison Hotel) and thank all of you that reached out to your Senators and House Members regarding NAC and JRJ funding. I also want to thank the entire Board and the Executive Committee for allowing me to serve at the Olympics and represent our great country.
