# **NDAA** Bids a **Fond Farewell** to NTLC Director Joanne Thomka

As she embarks on this exciting new chapter of her life, it is with both joy and a tinge of sadness that we bid Joanne Thomka farewell. After 15 years with the National District Attorneys Association (NDAA) as the Director of the National Traffic Law Center (NTLC), Joanne is retiring; her last day will be March 29. While this marks the end of an era for all of us here at the NDAA, it also heralds the beginning of a well-deserved period of relaxation, exploration, and new adventures for Joanne and her husband, Wayde.

Prior to joining NDAA, Joanne was a Senior Assistant District Attorney for the Onondaga County District Attorney's Office in Syracuse, New York, where she was the Bureau Chief of the DWI Unit, the Unit responsible for the prosecution of all alcohol-related crimes and vehicular fatalities. While at the Onondaga County DA's Office, Joanne also served as a member of both the Special Victims and Violent Felony Bureaus. Her passion and zeal for justice and victims'

rights were obvious from the start. As a prosecutor, she was tireless both in and out of the courtroom in her resolve to champion the rights of vehicular crime victims and to make our highways safer.

With the same tenacity and determination Joanne used to serve and protect the citizens of Syracuse, she delivered at the national level when she joined NDAA in 2006.1 Her tenure as the Director of the NTLC showcased her deep expertise in traffic safety. She exemplified NTLC's mission "to improve the quality of justice in traffic safety adjudications by increasing the awareness of highway safety issues through the compilation, creation and dissemination of legal and technical information, and by providing training and reference services." Joanne provided instrumental and essential legal resources for vehicular crimes prosecutors and law enforcement officers across the country. During her career, Joanne continued to teach prosecutors, law enforcement, and other traffic safety personnel on issues pertaining to impaired driving, trial advocacy, and other highway safety

issues. She spearheaded the planning and publication of numerous monographs and helpful manuals, including

on such topics as cannabis-impaired driving, drug toxicology, constitutional law, and issues important to commercial driver's licenses. She additionally expanded the training courses NTLC offered and developed new curricula on topics including drugimpaired driving, human trafficking, and masking.

She personally shared her knowledge with traffic safety professionals in nearly every state. Over the years, she enjoyed close relationships with numerous Traffic Safety Resource Prosecutors and helped train and educate thousands of prosecutors, law enforcement officers, and judges from across the country on a variety of issues connected to highway safety. As an instructor Joanne is famous for her

passion, skill, and practical advice. She is a true leader, motivating all who listen to her. All students became better, more dedicated, and effective practitioners as a result of Joanne's lessons and counsel.

With her vast experience in the traffic safety community, Joanne also participated in and was a member of several traffic safety-related committees, including work with the Transportation Research Board's (TRB) Traffic Law Enforcement Committee, the National Sheriffs' Association's (NSA) Traffic Safety Committee, the Traffic Injury Research Foundation's DWI Working Group, and the National Alliance to Stop Impaired Driving (NASID) to name but a few. Joanne's contributions and dedication to traffic safety were recognized with prestigious awards which include the 2013 J. Stannard Baker Award, presented by the National Sheriff's Association and the National Highway Traffic Safety Administration (NHTSA) in recognition for Outstanding Achievement in Highway

From 2015 to 2018, during her sabbatical from NDAA, Joanne served as a Program Counsel at the National Association of Attorneys General (NAAG). NAAG staff works to help attorneys general respond effectively—individually and collectively—to emerging state and federal issues. In her role as Program Counsel, Joanne was the staff liaison to the attorney general community for traffic safety, substance abuse, and elder issues.
