If you fall within one of the categories listed, you are eligible for NDAA membership:

ACTIVE MEMBER Each person of good moral character holding any of the following offices in any of the districts, counties, parishes, or municipalities of the U.S. or any of its districts, territories, or possessions shall be eligible for active membership:

- (a) Chief elected or appointed prosecuting attorney in a district, county, or comparable jurisdiction.
- (b) State Attorneys General where they act as chief elected or appointed prosecuting attorneys in a district, county, or comparable jurisdiction.
- (c) Municipal prosecutors who are employees of the municipality and who don't do criminal defense work.

ASSOCIATE MEMBER Each person of good moral character holding any of the following offices or positions shall be eligible for associate membership:

- (a) Any assistant or deputy in any of the offices required to be held as prerequisite for active membership;
- (b) Any attorney at law who, as a member of the Armed Forces of the U.S., is charged with serving as an attorney in the enforcement of military or criminal law;
- (c) Any person serving the Dominion of Canada or any other country or any of their political subdivisions who, were he similarly employed in the U.S., would be eligible for active associate membership;
- (d) Any United States Attorney and any Assistant United States Attorney and any attorneys in the office of the Attorney General of the United States.

ADMINISTRATOR Any person who holds the position of administrative assistant, office administrator, or anyone of similar title and function, for any individual coming within one of the offices designated under the Active Member classification.

BOARD ALUMNI MEMBER Any former member of the Board of Directors whose term of office has expired.

EXECUTIVE DIRECTOR AND/OR PROSECUTOR COORDINATORS Any person or persons who hold the position of Executive Director of any state prosecuting attorneys association or similar title in any group; and any person or persons who have the responsibility of administering the training needs of any group of prosecuting attorneys.

INVESTIGATORS Any person who holds the position of an investigator assigned to, or a full time employee of, a person coming within one of the offices designated under the Active Member classification.

LAW STUDENT Any student attending an accredited law school on a full-time or part-time basis who is working towards an L.L.B or J.D.

PROSECUTORS SUPPORT PERSONNEL Any person who holds a support position (i.e. secretary, paralegal, automation specialist, public relations director, clerical); and any and all others in positions of any similar titles or like functions.

SUSTAINING MEMBERS Persons or corporations who are donors of funds to this corporation to assist it in carrying out and furthering its objects and purposes shall, upon invitation of the Board of Directors of this corporation, be eligible to become sustaining members of this corporation.

WOMEN PROSECUTORS SECTION Membership is available to anyone who is already a member of NDAA. Membership in the association is required but no additional fees will be assessed.
