NDAА UNVEILS EYE-OPENING NATIONAL PROSECUTOR RETENTION SURVEY FINDINGS & LAUNCHES COMPREHENSIVE RESOURCE HUB

Arlington, VA – The National District Attorneys Association (NDAA) has released groundbreaking findings from the [2024 National Prosecutor Retention Survey \(NPRS\)](#), shedding light on the critical challenges faced by prosecutors nationwide. This eye-opening survey reveals that while an overwhelming 93% of prosecutors enjoy their work, a significant number are considering leaving the profession due to factors such as personal well-being, inadequate pay, and heavy caseloads.

Key Findings from the National Prosecutor Retention Survey:

- **93%** of prosecutors report high job satisfaction.
- **67%** are driven by their commitment to serving their community.
- **57%** have considered leaving the profession, citing personal well-being, better pay, and overwhelming caseloads as the primary reasons.

These findings underscore the urgent need for systemic changes to support and retain our dedicated prosecutors.
