Damon Mosler

Damon Mosler has been a San Diego County Deputy District Attorney for over 27 years and is currently the Chief of the Economic Crimes Division. He has served as Chief of both the Narcotics Division and Special Operations as well as a law enforcement liaison for the San Diego County Sheriff's Department. He has taught on a range of topics including: case preparation, predator/club drugs, informant handling, 4th amendment law and body worn camera concerns. He is a body worn camera subject matter expert for the Bureau of Justice Assistance.



Theresa Fuller

Teresa Fuller is the Manager of Victim Services and Adult Diversion for the Pinal County Attorney's Office. For 13 years, Mrs. Fuller has worked with various governmental capacities within Child Protective Services, Adult Probation, and Juvenile Probation. Throughout her career she has initiated or participated in innovative projects aimed at increasing the availability of evidence-based alternatives for community-supervision, including *Teen Court*, the *Crossover Youth Project*, adoption of *EPICS* training for supervisors and diversion officers, and development of policies for increasing evidence-based practices in community supervision.



Patrick Muscat

Patrick Muscat currently serves as the Deputy Chief of the Special Prosecutions Division overseeing the Homicide Unit, the Major Drug Unit, the Community Prosecution Unit, the Violent Crime/Grand Jury Unit, and the Crime Lab Liaison Unit of Wayne County Prosecutor's Office. Muscat is also the project manager for several federal grants in his office (Police/Prosecutor Initiative, Project Safe Neighborhoods, NIBIN, and Innovative Prosecutions Violent Crime/Opioids). In February of 2017, Pat was awarded the Prosecuting Attorneys Association of Michigan's *Distinguished Faculty Award*. Pat has been an adjunct law professor at the University of Detroit Mercy School of Law teaching *Litigation Technology* 635 since 2008.



Jennifer Webb-McRae

Jennifer Webb-McRae has been the Cumberland County Prosecutor since January of 2010. She is the first female, first African American and first full-time Prosecutor to be re-nominated in Cumberland County. As Prosecutor, Jennifer is the Chief Law Enforcement Officer in Cumberland County. She also served as the Child Support Attorney for the Cumberland County Welfare Board and as solicitor for the Fairfield Township Planning Board and the Cumberland County Construction Board. Jennifer also was an Assistant Deputy Public Defender for over six years before entering private practice. Jennifer has received numerous awards for her service to the community including the Diversity and Leadership Award from the Puerto Rican Action Commitment of New Jersey (2016), Juvenile Detention Alternatives Champion Award (2013) and the Greater Vineland NAACP Community Award (2009).
