Dear Members of the United States Senate and United States House of Representatives,

We, the undersigned elected and appointed chief prosecutors from jurisdictions around the country, are reaching out in collaboration with the National District Attorneys Association (NDAA) to urge Congress to immediately identify potential solutions for bridge funding to avert proposed spending cuts to the Victims of Crime Act (VOCA) Grants and the pending crisis that will negatively impact crime victims and jeopardize lives. Further, Congress must find a permanent solution to the declining deposits in the Crime Victims Fund (CVF). Exploring additional mechanisms for funding the CVF is critical to reverse declining deposits.

President Biden's Fiscal Year 2024 budget request allocated \$1.2 billion for victim service programs, compared to \$1.9 billion approved in Fiscal Year 2023 by Congress (a \$700 million reduction/41% decrease). The U.S. Senate Appropriations Committee approved \$1.2 billion on July 13, 2023, for Fiscal Year 2024, and the House Appropriations Committee is proposing the same reduction.

As you know, VOCA grants are the primary source of federal funding for thousands of victim service providers across the nation, including programs serving victims of domestic violence, sexual assault, child abuse, trafficking, and drunk driving. VOCA grants also fund victim compensation, which helps survivors pay medical bills, makes up for lost wages, and, in the most severe cases, helps pay for funeral costs.

Additionally, VOCA grants are non-taxpayer sources of funding supported by monetary penalties associated with federal criminal convictions and deferred and non-prosecution agreements. These penalties are deposited into the Crime Victims Fund (CVF), and Appropriators decide how much to release from the CVF every year.

Unfortunately, criminal prosecutions and fines associated with these crimes are at a two-decade low, and the CVF has experienced a number of years of concerningly low deposits. At the same time, the need for these services continues to grow. Congress passed the bipartisan, bicameral *VOCA Fix Act in 2021* to help stabilize the CVF which now directs all penalties/fines collected by DOJ in criminal prosecutions into the Fund. But even with these additional deposits, the CVF has not yet recovered to be able to fully fund critical and needed services.

The VOCA Fix was an important step, but without Congressional action, victim service providers will be forced to cut critical services, and many will be forced to close. Millions of victims, including abused children and battered women, will be left without access to safety, justice and healing. The impact will be most severe on the smallest programs, particularly programs in rural communities, low-income communities, and communities of color. Potentially tens of millions of victims nationwide will lose access to lifesaving and life-sustaining child abuse, domestic violence, sexual assault, elder abuse, and other victim services. Without access to these critical services, the real-time impact will not only be felt by individuals and families, but also in communities nationwide.

Victims and survivors urgently need a mechanism to provide bridge funding to VOCA at its current level of \$1.9 billion (which is already lower than any of the previous eight years) and prevent the collapse of America's victim service infrastructure.

We thank you for your willingness to consider bridge funding for VOCA and a permanent funding solution for the Crime Victims Fund.
