### ***Associate Justice of the Minnesota Supreme Court, Anne McKeig***

Anne McKeig was appointed as an associate justice of the Minnesota Supreme Court on September 1, 2016 as its first Native American justice by Governor Mark Dayton. Anne

previously served as a judge of the Minnesota Fourth District Court in Hennepin County from 2008 to 2016 and as Assistant Hennepin County Attorney, Child Protection Division from 1992 to 2008, specializing in Native American child welfare cases.

Associate Justice McKeig received her J.D. from Hamline University School of Law in 1992 and her B.A. from the College of St. Catherine in 1989.

Raised in Federal Dam, Minnesota, Anne attended Northland Regional High School in Remer, Minnesota. She is a descendant of the White Earth Band of Ojibwe.
